Deputy Secretary of Education, Fran Bradford

- Thank you! This work is equally if not, more important, than before.
 - Praise for the conference.
- Report out
 - Guidance with workforce programs (w/Lee Andes)
 - Increase qualifiers to grow access
 - Re-allot 2nd year of need-based financial aid
 - Using SCHEV model for distribution
 - Raise tuition assistance grant as was last year before it was re-allotted
 - The G3 program (Get skilled, get a job, and give back)
 - A lot like what passed last year.
 - High workforce need programs
 - Depending on income, it could not only be funded, but there might be funding for child-care, transportation, etc.
 - This year, beyond state budget, it's codified into legislation as well
 - Not officially rolled out legislative package
 - State need-based financial aid for undocumented students
 - Even if it passes, we doubt that it will be ready by Fall 2021
 - Students would be eligible for VTAG program (easier to do)
 - This might be an initial approval before everything else
 - FAFSA completion rate increase
 - Luisiana requires it unless you opt out, Tennessee dramatically improved, support & wrap-around services crucial
 - Regardless of legislation, how do we develop those support services

- Not likely to roll out for Fall 2021, VCAN's role in infrastructure
