- Approval of August Minutes & October Agenda: Scott
  - Scott Kemp calls for revisions to August meeting minutes
  - $\circ~$  Anne Michie moves to approve minutes; Lyons Sanchezconcha seconds; Motion passes unanimously
- 2022 Conference Update: Josh
  - Presidential reception secured for the first evening with JMU president as the speaker; will include heavy hors d'oeuvres and adult beverages
  - Official photographer confirmed with Stellar Exposures
    - They will provide images we will be able to use for the website and future advertising
    - All attendees will have access to the photographer during breaks to take professional headshots
  - Presenters have been confirmed for breakout sessions, though there are two current spots open in the schedule
  - Myesha Challenger has been identified as the keynote speaker but not yet

confirmed

- Hotel Madison update
  - Hotel room rate should be rectified for those who received the incorrect room rate previously
  - AV price is a little higher (around \$18k) than in the past, but will include new additions such as professional uplighting and a stage with draping and multiple screens
  - Food and beverage pricing has been whittled down to \$41k for about 220 guests
- 213 registrants to date; the room capacity is 300
- Information about sponsor levels will be shared soon to solicit additional sponsorships; ECMC and Virginia529 already confirmed as conference sponsors
- Request of the Board to assist with two specific needs:
  - An opening and closing speaker (a list of current speakers will come via Scott)
  - Two breakout session presenters
- Treasurer's report: Jan
  - Bank balance as of 9/30/22: \$102,352.80
  - All deposits for the month of September are conference registrations and one sponsorship check from ECMC.
  - One expenditure for September: conference photographer, Stellar Exposures.
  - Upcoming transactions:

      - Article 7: Requirement for a two-thirds majority for bylaw changes
  - Call for additional comment before adopting changes; no comments or questions raised
  - Lyons Sanchezconcha moves to approve the revision to the bylaws effective today; Anne Michie seconds; Motion passes unanimously
- Elections Process for 2023 Executive positions: Scott
  - Open Positions: President; Vice-President; Secretary; Treasurer
    - Scott's service will conclude at the end of this year. All other positions are eligible for reinstatement
  - Collection of candidates done virtually and presented to the Board by November 15, 2022. Candidate nominations (including self-nominations) should go to Anne Michie.
